

## Minutes

The Occupational Therapy Advisory Committee of the Board of Medical Licensure and Supervision met on February 7, 2023, in accordance with the Oklahoma Open Meeting Act. Advance notice of this regular meeting was transmitted to the Oklahoma Secretary of State on November 22, 2022. The notice and agenda were posted on the Board's website on February 3, 2023, at 11:31 AM pursuant to 25 O.S. § 311(A)(9).

Having noted a quorum, Barbara Smith, Executive Secretary, called the meeting to order at 9:00 a.m.

Following Committee review, Ms. White moved to accept the meeting minutes of October 20, 2022 as written. Ms. Garza seconded the motion and the vote was unanimous in the affirmative.

**KRISTINA BERRY** appeared virtually in support of her application for Occupational Therapy Assistant licensure. This application is currently incomplete. Her Oklahoma license expired October 31st of 2014 and she last practiced in April of 2013. Her certification is current through 2025 and she is licensed in Arkansas. Following review and discussion, Ms. White moved to recommend approval pending completion of the file to include providing proof of continued employment as an Occupational Therapy practitioner in the state of Arkansas. Ms. Garza seconded the motion and the vote was unanimous in the affirmative.

**ERNEST BLITCH** appeared personally in support of his application for Occupational Therapy Assistant licensure. This application is incomplete. He last practiced in July of 2021 and his certification expired on March 31, 2014. Mr. Blitch stated he has plans to reinstate his certification and he has completed 32 CEUs including NBCOT's Navigator. Following review and discussion, Ms. Garza moved to recommend approval of the application to include completion of the file and providing proof of obtaining 36 CEUs for 18 months of practice lapse. Ms. White seconded the motion and the vote was unanimous in the affirmative.

**SARAH CARRAWAY** appeared virtually in support of her application for Occupational Therapist licensure. This application is complete. She last practiced in March of 2021 and her

certification is active through 2025. She stated she earned CEUs in February of 2022. Following review and discussion, Ms. White moved to recommend approval of the application pending providing proof of obtaining 44 CEUs no later than February 28, 2023, or providing proof of current licensure in another state. Ms. Garza seconded the motion and the vote was unanimous in the affirmative.

**MOLLY DETERS** appeared virtually in support of her application for Occupational Therapist licensure. This application is incomplete. Her certification is current and she holds four state licenses. Following review and discussion, Ms. White moved to recommend approval of the application pending completion of the file to include providing proof of continued employment as an OT practitioner with no lapse in practice. Ms. Wallace seconded the motion and the vote was unanimous in the affirmative.

Next, the Committee reviewed applications for licensure. Ms. Garza moved to recommend approval of the incomplete applications for Occupational Therapy Assistant licensure pending completion of the files as listed on *Attachment #1* hereto. Ms. White seconded the motion and the vote was unanimous in the affirmative.

Ms. White moved to recommend approval of the incomplete applications for reinstatement of Occupational Therapy Assistant licensure pending completion of the file as listed on *Attachment #1* hereto. Ms. Garza seconded the motion and the vote was unanimous in the affirmative.

Ms. Garza moved to recommend approval of the complete applications for Occupational Therapy Assistant licensure as listed on *Attachment #1* hereto. Ms. Wallace seconded the motion and the vote was unanimous in the affirmative.

Ms. White moved to recommend approval of the incomplete applications for Occupational Therapist licensure pending completion of the files as listed on *Attachment #1* hereto. Ms. Wallace seconded the motion and the vote was unanimous in the affirmative.

Ms. Garza moved to recommend approval of the incomplete application for reinstatement of Occupational Therapist licensure pending completion of the file as listed on *Attachment #1* hereto. Ms. White seconded the motion and the vote was unanimous in the affirmative.

Ms. Wallace moved to recommend approval of the complete applications for Occupational Therapist licensure as listed on *Attachment #1* hereto. Ms. Garza seconded the motion and the vote was unanimous in the affirmative.

Next, Valeska Barr presented CEU courses previously recommended for approval by the reviewers. Ms. Garza moved to recommend approval of the CEU courses indicated on *Attachment #2* hereto which were previously recommended for approval by the reviewers. Ms. Wallace seconded the motion and the vote was unanimous in the affirmative.

Then Valeska Barr presented results of the 2022 continuing education audit pursuant to Okla. Admin. Code 435:30-1-5(b) and (b)(6)(F). She reported that 119 OTA files and 116 OT files were audited. Following review and discussion, Ms. Garza moved to refer the non-compliant licensees shown on *Attachment #3* hereto to the Oklahoma Medical Board for investigation and possible assessment of penalties pursuant to Okla. Admin. Code. 435:30-1-5. Ms. White seconded the motion and the vote was unanimous in the affirmative.

Next, the Committee welcomed the virtual classes of Oklahoma City Community College Occupational Therapy Assistant students and the Indian Capital Technology Center-Connors State College Occupational Therapy Assistant students. The committee members answered questions from the students and the students thanked the committee for its time.

There being no further business, Ms. Garza moved to adjourn the meeting. The time was 11:01 a.m.

**Oklahoma Administrative Code 435:30-1-5. License renewal; late fees; continuing education; re-entry guidelines****(b) Continuing education for renewal.**

(1) Continuing education for renewal of licensure has been established to require therapists' involvement in activities which keep their skills and knowledge of current practice up to date. A point is the equivalent of 1 contact hour. Twenty contact hours every 2 years will be required. **Penalties for failure to comply with continuing education requirements may be assessed after notice and hearing as required by law. Penalties may include imposition of additional continuing education contact hours, probation of license, suspension of license, or revocation of license. Failure to produce records of continuing education rebuts the presumption that continuing education requirements have been completed. The willful and intentional misrepresentation of compliance with continuing education requirements shall constitute prima facie evidence of a fraudulent application for licensure renewal.**

(b)(6)(F) A summarized report shall be submitted to the Occupational Therapy Committee listing the names of those audited who are in compliance with continuing education requirements. Those not in compliance shall be listed with notation of deficiencies found and/or recommendation.
