This CONTRACT is made and entered into by and between the Oklahoma State Board of Osteopathic Examiners, hereinafter referred to as **OSBOE** and _____.

Now, therefore, in consideration of the covenants and agreements hereinafter set forth, it is mutually agreed between the above parties the following:

1. **OSBOE** will incorporate, where and when feasible, certain data attributes in the **OSBOE** Physician Databases pertinent to our on-line members' needs regarding analysis of Oklahoma licensed Osteopathic physicians.
2. **OSBOE** will provide for on-line members a Secure Web access to **OSBOE** Physician Databases. This service is an added option to the Subscriber Service option hosted by The Oklahoma State Board of Medical Licensure & Supervision (*OSBMLS*) on its website at www.okmedicalboard.org . The Online member understands and agrees that they, to qualify for this service, must be a current subscriber of *OSBMLS*' web-based subscriber service.
3. The On-line member should keep user name and password under strict confidence. Any abuse or misuse of username and password will result in immediate cancellation of this service.
4. On-line users will pay **OSBOE** according to attached fee schedule. These monies will cover the services set forth herein.

5. On-line members agree to use the information retrieved from **OSBOE** database strictly for business use only. Use of information retrieved for anything but business purpose will result in immediate cancellation of all services.
6. Information provided through the web site is an exact copy of the database and may be used as a primary source of verification. Web site information is updated everyday to reflect changes in the database. Name, address and other information on all licensees and applicants are accurate as to the most current information on file at the Board.
7. Any party hereto may cancel or terminate this CONTRACT upon a 30-day written notice. Notice required under this provision of the CONTRACT shall be sent to the addresses set forth above.
8. All services provided by **OSBOE** pursuant to this CONTRACT shall be at the present fair market value for such services. The present fee schedule is attached as an example only and the exact price charged by **OSBOE** shall be the fair market value for such services as shown on the current fee schedule, at the time such services are rendered. **OSBOE** reserves the right to change the fee schedule to cover the cost of providing the services. **OSBOE** shall provide its online subscribers, 30-day advance written notice of changes to monthly subscriber fees.
