Patel, MD** – Disciplinary hearing alleging aiding or abetting a criminal operation; conviction of a felony or of any offense involving moral turpitude; dishonorable conduct likely to deceive, defraud, or harm the public; the commission of any act which is a violation of the criminal laws of any state when such act is connected with the physician’s practice of medicine; prescribing or administering a drug or treatment without sufficient examination and the establishment of a physician-patient relationship; the violation of any of the provisions of the Oklahoma Medical Act, obtaining any fee by fraud, and abuse of the physician’s position of trust by coercion, manipulation or fraud.

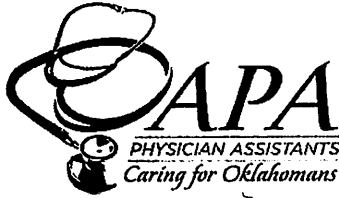
