through V, as defined by the Uniform Controlled Dangerous Substances Act, for the physician's personal use; fraud or misrepresentation in applying for or procuring a medical license or in connection with applying for or procuring periodic reregistration of a medical license; and using a false, fraudulent or deceptive statement in a document connected with the practice of medicine and surgery.
