DISCIPLINARY MATTERS

___ ***MARK NOLAN HILL, MD** – Disciplinary hearing on allegations of violation, or attempted violation, direct or indirect, of any of the provisions of the Oklahoma Allopathic Medical and Surgical Licensure and Supervision Act, either as principal, accessory or accomplice; receiving disciplinary action from another state or jurisdiction; making a misrepresentation in applying for or procuring a medical license or in connection with applying for or procuring periodic re-registration of a medical license; engaged in the use of any false, fraudulent, or deceptive statement in any document connected with the practice of medicine and surgery.

___ ***LINDA LUCIO, MD** – Disciplinary hearing on allegations of inability to practice medicine with reasonable skill and safety to patients by reason of age, illness, drunkenness, excessive use of drugs, narcotics, chemicals, or any other type of material or as a result of any mental or physical condition. In enforcing this subsection the Board may, upon probable cause, request a physician to submit to a mental or physical examination by physicians designated by it; conduct likely to deceive, defraud, or harm the public; confession of a crime involving violation of the laws of this state; *and* the habitual or excessive use of any drug which impairs the ability to practice medicine with reasonable skill and safety to the patient.

___ ***MELITA TATE, MD** – Disciplinary hearing on allegations of prescribing or administering a drug or treatment without sufficient examination and the establishment of a valid physician-patient relationship; violation, or attempted violation, direct or indirect, of any of the provisions of the Oklahoma Allopathic Medical and Surgical Licensure and Supervision Act, either as a principal, accessory or accomplice; aiding or abetting, directly or indirectly, the practice of medicine by any person not duly authorized under the laws of this state; failure to maintain an office record for each patient which accurately reflects the evaluation, treatment, and medical necessity of treatment of the patient; failure to provide a proper and safe medical facility

setting and qualified assistive personnel for a recognized medical act, including but not limited to an initial in-person patient examination, office surgery, diagnostic service or any other medical procedure or any other medical procedure or treatment. (Adequate medical records to support diagnosis, procedure, treatment or prescribed medications must be produced and maintained); and failure to establish a physician/patient relationship prior to providing patient-specific medical services, care or treatment, except in a clearly emergent, life threatening situation.

- ___ ***JASON TYLER STANSILL, MD** – Disciplinary hearing on allegations of habitual intemperance or the habitual use of habit-forming drugs; dishonorable or immoral conduct which is likely to deceive, defraud, or harm the public; engaging in physical conduct with a patient which is sexual in nature, or in any verbal behavior which is seductive or sexually demeaning to a patient; the habitual or excessive use of any drug which impairs the ability to practice medicine with reasonable skill and safety to the patient; conduct likely to deceive, defraud, or harm the public; commission of any act of sexual abuse, misconduct, or exploitation related or unrelated to the licensee's practice of medicine and surgery; and abuse of physician's position of trust by coercion, manipulation or fraudulent representation in the doctor-patient relationship.
