Permanent rule amendments adopted –
OAC 435:50-5-3. Continuing education requirements for renewal (Pedorthists)

Proposed rule allowing Physical Therapists to extend a physical therapy prescription for a reasonable number of days (up to 90 days) when clinically indicated by a physician – approved to proceed with rulemaking process
