KAREN STEVENSON, OTA – Disciplinary matter alleging dishonorable or immoral conduct likely to deceive; the habitual use of habit forming drugs; confession of a crime involving violation of antinarcotic laws; violation or attempted violation of any of the provisions of the Oklahoma Allopathic Medical and Surgical Licensure and Supervision Act; unauthorized possession or use of illegal or controlled substances; and violation of the terms and conditions of probation instituted on January 15, 2015 - *Surrender in Lieu of Prosecution accepted pending review of the Oklahoma Attorney General*

DWAYNE LEWIS ROUSH, MD – Disciplinary hearing alleging dishonorable or immoral conduct likely to deceive; indiscriminate or excessive prescribing, dispensing or administering of a controlled substance or narcotic drug; failure to maintain an accurate office record for each patient; dispensing, prescribing or administering a controlled substance or narcotic drug without medical need; and conviction of any offense involving moral turpitude - *Motion to Continue granted until the January 2017 Board Agenda with restrictions on license pending review by the Oklahoma Attorney General*

BRUCE THOMPSON, MD – Disciplinary hearing alleging prescribing, dispenses or administering controlled substances or narcotic drugs without medical need; commission of an act which is a violation of the criminal laws of any state connected with the physician's practice of medicine; prescribing or administering a drug without sufficient examination and the establishment of physician-patient relationship; failure to maintain appropriate and accurate office records; violation of state or federal law or regulation related to controlled substances; failure to cooperate with a lawful investigation conducted by the Board and to furnish the Board information lawfully requested; and improper use of controlled substances for the management of chronic pain – *Indefinite suspension pending review of the Oklahoma Attorney General*

DENNIS RIVERO, MD – Defendant's Motion for Summary Judgment and, dependent upon the ruling on Defendant's Motion for Summary Judgment, possible disciplinary hearing alleging failure to provide a proper and safe medical facility setting and qualified assistive personnel; gross or repeated negligence in the practice of medicine; fraud or misrepresentation in applying for/procuring a medical license; falsifying statements in any document connected with the practice of medicine; and an adverse judgment or settlement arising from a medical liability claim - *Case dismissed.*
