### Disciplinary Hearings

**BRYAN JOSEPH TREACY, MD** – Disciplinary hearing alleging engaging in dishonorable or immoral conduct; violation of state or federal controlled dangerous substance laws; disciplinary action in another state; and violation of Board Order – *Voluntary Submittal to Jurisdiction accepted pending review of the Oklahoma Attorney General.*

**BRYAN LEE, MD** – Disciplinary hearing alleging dishonorable or immoral conduct; prescribing violations; controlled dangerous substance/narcotic drugs violations; office/medical records violations; medical setting/facility violations; receiving compensation for services not rendered; using a false statement connected with the practice of medicine; failing to cooperate with a lawful investigation; abuse of physician's position of trust; and failing to establish a physician/patient relationship prior to treatment – *Voluntary Submittal to Jurisdiction accepted pending review of the Oklahoma Attorney General.*

**JERRY HERNANDEZ, MD** – Disciplinary hearing alleging habitual use of habit-forming drugs; violation of the criminal laws connected with the practice of medicine; excessive use of any drug which impairs the ability to practice medicine; and violation of CDS laws and regulations – *Voluntary Submittal to Jurisdiction accepted pending review of the Oklahoma Attorney General.*

**ROGER LEE KINNEY, MD** – Disciplinary hearing alleging dishonorable conduct likely to deceive the public; controlled dangerous substances violations; medical records violations; the excessive prescribing, or prescribing without medical need, of controlled dangerous substances or narcotic drugs – *Voluntary Submittal to Jurisdiction denied and disciplinary hearing scheduled for January 12, 2017.*

**PETRINA NESBITT, RC**– Disciplinary hearing alleging dishonorable conduct likely to deceive; habitual use of intoxicating liquors or habit-forming drugs which could result in behavior which interferes with the practice of respiratory care; conviction of, confession or plea of no contest to drug-related offense; and violation of any provision of the Medical Practice Act or the rules promulgated by the Board – *Public reprimand, obtain an official assessment by Board-approved provider within the next six months, sign a five-year contract with Oklahoma Health Professionals Program and probation to run concurrently therewith pending review of the Oklahoma Attorney General.*
