## Disciplinary Hearings

**JAMES MICHAEL FERRIS, JR., MD** – Disciplinary hearing alleging dishonorable or immoral conduct likely to deceive; violating the criminal laws of this State connected with the physician’s practice of medicine; writing false or fictitious prescriptions; prescribing or administering a drug or treatment without valid physician-patient relationship; failing to provide necessary ongoing medical treatment; aiding or abetting the practice of medicine by an unlicensed person; improper management of medical records; violating the rules of Oklahoma Bureau of Narcotics; and violating the provisions of the Oklahoma Medical and Surgical Act – *Imposed a one-month suspension, a \$5,000 administrative fine, and a CME ethics and prescribing course approved by Board Secretary, pending review by the Oklahoma Attorney General.*

**JAMES ROBERT COLVERT, MD** – Disciplinary hearing alleging habitual intemperance or the habitual use of habit forming drugs; confession of a crime involving the violation of the laws of this State; and the inability to practice medicine with reasonable skill and safety to patients by reason of age, illness, drunkenness, excessive use of drugs, narcotics, chemicals or any other mental or physical condition – *Surrender in Lieu of Prosecution accepted pending review by the Oklahoma Attorney General.*

**PETRINA NESBITT, RC** – State's Motion to Modify Board Order (subsequent to review of follow-up information pursuant to Board's ruling on November 3, 2016) – *Granted pending review by the Oklahoma Attorney General.*

**LESLIE ANN MASTERS, MD** – Disciplinary hearing alleging engaging in dishonorable or immoral conduct likely to deceive, defraud or harm; medical records violations; gross or repeated negligence in the practice of medicine and surgery; engaging in behavior demonstrating an incapacity or incompetence to practice medicine and surgery; and failing to provide a proper and safe medical facility setting – *Voluntary Submittal to Jurisdiction denied.*

**DWAYNE LEWIS ROUSH, MD** – Disciplinary hearing alleging dishonorable or immoral conduct likely to deceive; indiscriminate or excessive prescribing, dispensing or administering of a controlled substance or narcotic drug; failure to maintain an accurate office record for each patient; dispensing, prescribing or administering a controlled substance or narcotic drug without medical need; and conviction of any offense involving moral turpitude – *Imposed a six-month suspension, a \$10,000 administrative fine, mental health evaluation, continuing education courses on prescribing and documentation all to be approved by Board Secretary, and return to the Board in six months, pending review by the Oklahoma Attorney General.*

**SCOTT GREGORY LILLY, MD** – Disciplinary hearing alleging administering a drug or treatment without establishing valid physician-patient relationship; engaging in dishonorable or immoral conduct; violating controlled substances and/or narcotics laws; failing to maintain appropriate office records; failing to provide necessary medical treatment; failing to provide a safe and proper medical facility and personnel; engaging in gross or repeated negligence; and violating Oklahoma Bureau of Narcotics rules (May 5, 2017) – *Proceeding began but was discontinued due to loss of quorum.*

Code 435:15-3-17[c]) to *"Is it permissible under Oklahoma law or federal constitutional law for a licensee to be required to report continuing medical education units (CMEs) obtained for the purpose of licensure to the voluntary state association and then be required to pay the state association a fee to have those CMEs reported to the Oklahoma State Medical Board of Licensure and Supervision, i.e, the licensing agency?"*

The Board *approved* a loan to provide **Oklahoma Board of Licensed Alcohol and Drug Counselors** with financial assistance
