## Disciplinary Hearings

**LESLIE ANN MASTERS, MD** – Disciplinary hearing on allegations of engaging in dishonorable or immoral conduct likely to deceive, defraud or harm; medical records violations; gross or repeated negligence in the practice of medicine and surgery; engaging in behavior demonstrating an incapacity or incompetence to practice medicine and surgery; and failing to provide a proper and safe medical facility setting - *Imposed sanctions of a 12-month suspension of medical license with a required personal appearance before the Board at the end of the 12 months, and a \$25,000 administrative fine pending review and approval of the Oklahoma Attorney General.*

**CYNTHIA CAROL ALMOND, MD** – Hearing on Immediate Summary Suspension of Medical License based on allegations of procuring, aiding or abetting a criminal operation; being convicted of a felony; engaging in dishonorable or immoral conduct which is likely to deceive, defraud or harm the public; engaging in behavior that demonstrates an incapacity or incompetence to practice medicine and surgery; violating any state or federal law or regulation relating to controlled substances; and violating any laws in the state in which she is practicing or any federal, territorial or district laws that are in effect in the location in which she is using her Oklahoma license to practice - *Upheld the suspension pending a full disciplinary hearing before the Board.*

**MEGAN RIDLEY, RC** – Disciplinary hearing on allegations of habitual use of habit-forming drugs; dishonorable or immoral conduct likely to deceive; inability to practice medicine with reasonable skill and safety; making false or deceptive statements in documents connected with the practice of medicine; controlled dangerous substances violations; failure to cooperate with a lawful investigation; habitual use of any drug which interferes with the practice of respiratory care; unauthorized possession of illegal or controlled dangerous substance without lawful authority; conduct which potentially or actually jeopardized a patient’s life; falsifying documents submitted to the Respiratory Care Advisory Committee or State Board of Medical Licensure and Supervision; violation of the Respiratory Care Practice Act or the rules promulgated by the State Board of Medical Licensure and Supervision; violation of any provision(s) of the medical practice act or the rules and regulations of the Board; and failure to demonstrate behavior that reflects integrity - *Surrender in Lieu of Prosecution accepted pending review and approval of the Oklahoma Attorney General.*

**SCOTT GREGORY LILLY, MD** – Disciplinary hearing on allegations of administering a drug or treatment without establishing valid physician-patient relationship; engaging in dishonorable or immoral conduct; violating controlled substances and/or narcotics laws; failing to maintain appropriate office records; failing to provide necessary medical treatment; failing to provide a safe and proper medical facility and personnel; engaging in gross or repeated negligence; and violating Oklahoma Bureau of Narcotics rules - *Imposed sanctions of a six-month suspension, no CDS prescribing, a \$20,000 administrative fine, prior approval of board secretary for any future practice locations, a lifetime contract with the Oklahoma Health Professionals Program, Inc., and inspections of specimens and medical records at the discretion of board staff pending review and approval of the Oklahoma Attorney General.*
