THOMAS KEITH JENKINS, PTA – Motion to Enforce Board Order based on allegations of violation of a contract executed by Defendant with the Allied Professional Peer Assistance Program ("APPA") on September 18, 2013 *and* possible hearing on Immediate Summary Suspension based on allegations of violation of a contract executed by Defendant with the Allied Professional Peer Assistance Program ("APPA") on September 18, 2013 – *Revocation based on the Motion to Enforce Board Order pending review and approval by*

the Oklahoma Attorney General. Based on the Board's ruling on the Motion to Enforce Board Order, the hearing on Defendant's Immediate Summary Suspension was moot.

FALISHA JONES, RC– Hearing on Immediate Summary Suspension based on allegations of violation of a contract executed by Defendant with the Allied Professional Peer Assistance Program ("APPA") on December 29, 2015 – *Upheld suspension pending the results of an assessment pending review and approval by the Oklahoma Attorney General.*

RENAE L. MAYER, MD, a/k/a RENAE BUFOGLE – Disciplinary hearing on allegations of habitual intemperance or the habitual use of habit-forming drugs; confession to a crime involving a violation of the anti-narcotic laws of the federal government or the laws of this state; writing false or fictitious prescriptions for any drugs or narcotics declared by the laws of this state to be controlled or narcotic drugs; prescribing any regulated substance in Schedule I through V, as defined by the Uniform Controlled Dangerous Substances Act, for the physician's personal use; prescribing a drug legally classified as a controlled substance or recognized as an addictive dangerous drug to a family member or to himself or herself; and violating any state or federal law or regulation relating to controlled substances – *Voluntary Submittal to Jurisdiction accepted pending review and approval by the Oklahoma Attorney General.*

ROGER LEE KINNEY, MD – Disciplinary hearing regarding allegations of dishonorable conduct likely to deceive the public; controlled dangerous substances violations; medical records violations; and the excessive prescribing, or prescribing without medical need, of controlled dangerous substances or narcotic drugs – *Three-month suspension, required CEU course, practice location to be approved by Board Secretary based upon recommendations of the KStar and neuropsych evaluations, and no prescribing of Schedule II or Suboxone pending review and approval by the Oklahoma Attorney General.*
