**FLOYD LEE SMITH, MD** – Disciplinary hearing based on allegations of prescribing or administering a drug or treatment without sufficient examination and the establishment of a valid physician-patient relationship; prescribing, dispensing or administering of controlled substances or narcotic drugs in excess of the amount considered good medical practice, or prescribing, dispensing or administering controlled substances or narcotic drugs without medical need; failure to maintain an office record for each patient which accurately reflects the evaluation, treatment, and medical necessity of treatment of the patient; prescribing, selling, administering, distributing, ordering, or giving any drug legally classified as a controlled substance or recognized as an addictive dangerous drug to a family member or to himself; and improper management of medical records – *Voluntary Submittal to Jurisdiction accepted.*
