The Committee reviewed a request from **PAUL ESTES, OT** to supervise an additional OTA, Candice Claudine Combs, OTA #574. Ms. White moved to approve Mr. Estes' request to supervise an additional OTA, Ms. Combs with the requirements that (1) documentation logging the hours she filled in for Mr. Estes' staff in the state which she holds a current license be presented at the next meeting of the Committee on April 2, 2015; and (2) she not work more than sixty (60) hours per calendar month under Mr. Estes' supervision. Ms. Hancock seconded the motion and the vote was unanimous in the affirmative.

The Committee discussed use of telehealth in the field of Occupational Therapy. Ms. Garza reported she recently attended the national conference in Washington, D.C. where she heard speakers discuss the growth and future of telehealth in Occupational Therapy as well as Physical Therapy.

Ms. Garza further reported that Oregon and Alaska presented their protocol for telehealth. Alaska does not allow OTs who are not licensed in Alaska to provide therapy because they want to protect the Alaskan culture.

A proposed telehealth survey was reviewed. The survey can be submitted via email to each OT and OTA licensed in Oklahoma. The email will contain a link to Survey Monkey and they will do results, tallying and reporting. Ms. White moved to send the telehealth survey to all licensees in the field of OT. Ms. Hancock seconded the motion and the vote was unanimous in the affirmative.

Kathy Plant advised the Committee that Shaun Conway from NBCOT requested to be allowed to present regarding services they offer and have a conversation regarding current issues they are facing. The Committee directed Staff to invite him to the April 2, 2015 meeting.

Lastly, the Committee directed Staff to put on the April 2, 2015 Agenda a discussion regarding how to best deal with lapses of time between graduation and application for licensure by licensees.

There being no further business, Ms. White moved to adjourn the meeting. Mr. Lee seconded the motion and the vote was unanimous in the affirmative. The time was 10:45 a.m.
