

Minutes

The Occupational Therapy Advisory Committee of the Board of Medical Licensure and Supervision met on April 6, 2017, in accordance with the Open Meeting Act. The meeting was held at the office of the Board, 101 NE 51st Street, Oklahoma City, Oklahoma. Advance notice of this meeting was transmitted to the Oklahoma Secretary of State on November 1, 2016, and posted on the Board's website on April 4, 2017. The notice and agenda were posted in prominent public view on the front doors of the Oklahoma Board of Medical Licensure and Supervision building located at 101 NE 51st Street, Oklahoma City, OK on April 4, 2017 at 9:30 a.m.

Having noted a quorum, Mr. Lee called the meeting to order at 9:00 a.m. and welcomed the visiting Occupational Therapy Assistant students from Oklahoma City Community College, Oklahoma City, Oklahoma.

Following Committee review, Ms. White moved to approve the minutes as written of the special meeting held on February 2, 2017. Ms. Hancock seconded the motion and the vote was unanimous in the affirmative.

Teresa Mitchell, Director of Licensing, announced that Applicant **LAUREN RICKER** was scheduled to appear via Skype and requested that the agenda be re-ordered to accommodate Ms. Ricker's schedule. Committee Chair agreed and the agenda was re-ordered.

SUSAN McBRIDE appeared in support of her application for Occupational Therapist licensure. Her application is complete. She graduated in 1989 and last practiced in 1992. Applicant stated that during that time she practiced full-time for 3 or 4 years and practiced just under a year part-time. Applicant holds active Florida and Utah licenses. She also is certified

through the National Board for Certification in Occupational Therapy ("NBCOT"). The Committee confirmed that this applicant qualifies for licensure by endorsement since she holds an active license in other states, but expressed concern with the amount of time the applicant has been out of practice. The applicant stated she is willing to work under a supervised registered Occupational Therapist if that is what the committee requires. She ultimately wants to work overseas and wants to achieve a level of expertise within the field she will be utilizing overseas and does not believe that is possible here without a license. Ms. White moved to recommend approval of the application of **SUSAN McBRIDE** for Occupational Therapist licensure pending completion of three months or 66 days of direct supervision with documentation from her supervising registered Occupational Therapist provided for staff review and obtaining a total of 100 continuing education units (50% of those to be direct/onsite and the remaining 50% may be direct/onsite or online). Ms. Hancock seconded the motion and the vote was unanimous in the affirmative.

RENITA BRAY appeared in support of her application for Occupational Therapy Assistant licensure. Ms. Bray graduated in January of 2015 and successfully passed the National Board for Certification in Occupational Therapy ("NBCOT") exam in March of 2017, but she has not had any clinical experience since graduation. She currently works as a home health aide. Her application is complete and she has met the requirements for licensure in Oklahoma. Applicant stated her employment intentions are to work with geriatric patients in home health after she gains clinical experience. Mr. Lee moved to recommend approval of **RENITA BRAY** for Occupational Therapist Assistant licensure. Ms. White seconded the motion and the vote was unanimous in the affirmative.

Next, **LAUREN RICKER** appeared via Skype in support of her application for Occupational Therapist licensure. She graduated in 2009 and last practiced in January of 2016. Ms. Ricker currently holds licenses in three other states, but her application is incomplete. The Committee reviewed certificates of continuing education units ("CEUs") which Applicant had previously provided. Mr. Lee moved to recommend approval of the application of **LAUREN RICKER** for Occupational Therapist licensure pending completion of the file to include twenty (20) hours of continuing education units as required for this compliance period. Ms. Hancock seconded the motion and the vote was unanimous in the affirmative.

SUZANNE KNIFFIN appeared in support of her application for reinstatement of Occupational Therapy Assistant licensure. Her application is incomplete. Ms. Kniffin's Oklahoma license was granted in 1998 and expired in 2006. She practiced fulltime as an OTA from 1998 to 2005. Applicant previously held a California license which expired in 2004. Ms. White moved to recommend approval of the application of **SUZANNE KNIFFIN** for Occupational Therapy Assistant licensure pending completion of the file to include three months or 66 days of direct supervision with documentation from a supervising registered Occupational Therapist provided for staff review and obtaining a total of 100 continuing education units (50% of those to be direct/onsite and the remaining 50% may be direct/onsite or online). Ms. Hancock seconded the motion and the vote was unanimous in the affirmative.

EMILY WILSON, Occupational Therapist, appeared with documentation of the 27 hours of direct on-site supervision and the 100 continuing education requirements as required by

the Committee in its meeting held in October of 2016. Ms. Wilson's application was approved in October of 2016 pending completion of these requirements and no further action was required by the Committee.

STEPHANIE AUSTIN appeared in support of her application for Occupational Therapy Assistant licensure. Her application is complete. Upon questioning by the Committee, Ms. Austin acknowledged she made bad choices in the past and will not make those mistakes again. Ms. Hancock moved to recommend approval of the application of **STEPHANIE AUSTIN** for Occupational Therapy Assistant licensure. Ms. White seconded the motion and the vote was unanimous in the affirmative.

LAUREN GISELLE SIMS MITCHELL appeared in support of her application for Occupational Therapy Assistant licensure. She graduated in May of 2016 and her application is incomplete. Ms. Mitchell stated she does not have a drug addiction but she was involved with an abusive boyfriend who was addicted. Because of criminal charges brought against her, she has a six-year deferred sentence. Ms. Mitchell was referred to the Allied Professional Peer Assistance Program but there was not a recommendation for treatment. Following Committee review of the file and discussion, Ms. White moved to recommend approval of the application of **LAUREN GISELLE SIMS MITCHELL** for Occupational Therapy Assistant licensure under terms of agreement to fulfill all terms of her legal deferment and pending completion of the file. Ms. Hancock seconded the motion and the vote was unanimous in the affirmative.

FELICIA JOHNSON appeared in support of her application for Occupational Therapy Assistant licensure. Her application is incomplete. She will graduate in May of 2017, but she has not yet contacted the National Board for Certification in Occupational Therapy ("NBCOT") to confirm her eligibility to sit for the exam. Ms. White moved to recommend approval of the application of **FELICIA JOHNSON** for Occupational Therapy Assistant pending completion of the file. Ms. Hancock seconded the motion and the vote was unanimous in the affirmative.

ANGIE TRINKLE, Occupational Therapist, appeared in support of her request to supervise three additional Occupational Therapy Assistants ("OTAs") for a total of seven OTAs under her supervision. Ms. Trinkle is employed with Moore Public Schools ("MPS"). She provided documentation of the clinical experience for each OTA to the Committee for its consideration. She stated that MPS has done an active job of recruiting for the position of Occupational Therapist, but has not been successful in filling the position to date. Following discussion of the Committee, Ms. White moved to deny the request of **ANGIE TRINKLE, Occupational Therapist**, for permission to supervise three additional Occupational Therapist Assistants. Ms. Hancock seconded the motion and the vote was unanimous in the affirmative. The Committee advised Ms. Trinkle that she needs to become very familiar with the supervising guidelines. Additionally, Ms. Trinkle needs to discuss the situation with her school system and let the school system know it needs to engage in an active recruiting process for Occupational Therapists.

MYKAL JORDAN, Occupational Therapist, appeared via Skype in support of her request to supervise a fifth Occupational Therapy Assistant ("OTA"). Ms. Jordan stated she does not have an active caseload at this time and that she primarily conducts evaluations and provides

supervision. In the home health setting, she conducts the evaluations and develops plans of care then discusses with the OTAs. In the nursing home setting, Ms. Jordan is normally present a couple days per week and the OTA is usually present at least for a portion of the evaluation. Treatment is discussed at that time as well. Ms. White moved to recommend granting permission, set to expire one year from this date, to **MYKAL JORDAN, Occupational Therapist**, to supervise a fifth Occupational Therapist Assistant, Erica Butler, with total supervising hours not to exceed 160 hours per week. Ms. Hancock seconded the motion and the vote was unanimous in the affirmative. The Committee recommended that Ms. Jordan keep a supervision contact log during this time of supervising a fifth Occupational Therapist Assistant.

MARY MATHEWS appeared in support of her application for reinstatement as an Occupational Therapy Assistant. Her application is complete. She has an active license in Iowa and works in a hospital setting in acute care. Ms. White moved to recommend approval of the application of **MARY MATHEWS** for reinstatement of her Occupational Therapy Assistant licensure. Mr. Lee seconded the motion and the vote was unanimous in the affirmative.

Next, the Committee reviewed supervision reports required of **PATRICIA DANIEL, Occupational Therapist**, by the Committee in its October 2016 meeting. No action was required on this matter.
