The Committee discussed OAC 435:15-11-1(d) as related to prescriptions for Schedules III, IV and V controlled medications limited to thirty-day supplies with no refills. The question was raised whether a prescription for 10 days plus two refills would comply with the rule as long as the total amount of medication did not exceed a 30-day supply. Mr. Coody said he felt the rule stated no refills, even if the initial prescription was for less than a 30-day supply. The doctor or PA could write another prescription if the patient needed more before the end of the 30 days or after.

After further discussion, Mr. Coody moved that it was the Committee's interpretation of the rule that the Physician Assistant could write for Schedules III, IV & V up to a 30-day quantity or supply but could not provide for refills and anything further would require a new prescription. Dr. Harris seconded the motion. The Committee asked that amending the rule to clarify the language be placed on the next agenda. Discussed was changing the wording of the rule to state that PAs may write a prescription for controlled dangerous substances in schedules III, IV, and V for up to a 30-day supply but refills for any amount would not be honored. The vote on the motion was called and was unanimous in the affirmative.

Rules relating to direct supervision during conscious sedation were discussed. Mr. Flinn said he had a request from PAs who work in emergency rooms to change the supervision level for conscious sedation from direct to general supervision. He said the PAs who do conscious sedation are specially trained and utilize it for suturing, reducing fractures, dislocations, etc. Dr. Harris asked about how often the procedure goes wrong. Mr. Flinn reported that last year at the Health Sciences Center, none of the procedures had gone wrong but three percent had to be reversed and that percentage included all individuals doing conscious sedation: physicians, residents, PAs, etc. The Committee discussed the need for fact-intensive research with guidelines. The *Practice Guidelines for Sedation and Analgesia by Non-Anesthesiologists* from the American Society of Anesthesiologists was reviewed. Under those guidelines, the procedures being talked about would fall under "moderate sedation". As written now, the rules require the physician to be on-site but not necessarily in the room.

The Committee discussed adding to language to the rules stating that the Board could consider waiving the direct supervision requirement to allow general supervision for minimal- and moderate-sedation after review of training and education based on the conscious sedation policy. The Board could then approve the applications on a case-by-case basis. Dr. Harris moved to adopt that language as a proposed, changing OAC 15-9-5 (f) to establish a section (5). Dr. Wootan seconded the motion and the vote was unanimous in the affirmative. Dr. Harris moved to develop a policy listing the

necessary training and experience requirements before sending the rule to Board. Dr. Wootan seconded the motion and the vote was unanimous in the affirmative.

A request from Dr. Meek was reviewed regarding PA dispensing medications as outlined in OAC 435:15-11-1 (i). Dr. Meek asked if the Department of Corrections qualified as a special patient care setting. The Committee had numerous questions about how the medications were dispensed or prescribed. After discussion, Mr. Coody moved to table the request and have Dr. McNeill obtain clarification from Dr. Meek regarding the request. Dr. Wootan seconded the motion and the vote was unanimous in the affirmative.

The Chair called for new business. Mr. Flinn said it had been brought to his attention that supervision of a PA in surgery has still been a little lacking. The PA has been starting the surgery, making decisions, harvesting bone grafts and then the surgeon will show up 30 minutes into the procedure. Mr. Flinn said he doesn't want other surgical PAs to be punished because of the actions of this one PA. The Committee discussed national guidelines on the use of PAs in surgery. Dr. McNeill said he would stress the proper use of PAs in surgery at the State PA meeting.

There being no further business, Mr. Coody moved to adjourn the meeting. Dr. Wootan seconded the motion and the vote was unanimous in the affirmative. The time was 4:45 p.m.
