Practice settings and supervision levels for new graduates were discussed. New graduates, by rule, cannot work in a remote patient care setting but can work in other settings where the supervising physician is not in the facility. Dr. McNeill said new graduates need to be in a structured and supervised setting. He recommended defining a new graduate practice setting that would require the primary or alternate supervising physician to be on-site a preponderance of the time. The Committee discussed developing a policy until a rule change could be made. Dr. McNeill stated he would work with staff to draft a policy for presentation at the next meeting.

Dr. Harris updated the Committee on a disciplinary case presented at the last meeting. The Committee had recommended to the Board that the license of the PA in question be permanently revoked. Dr. Harris reported that the Board felt, since the PA had not received quality in-patient treatment, she should not be permanently barred from licensure. The Board revoked her license with the ability to reapply in one year.

**RETA ANN BEARFACE** appeared in support of her application for Physician Assistant licensure. Ms. Bearface testified regarding the suspension of her privileges at Anadarko Indian Health Service Clinic. She stated that she had not renewed her South Dakota license, her only license, so IHS was required to suspend her privileges. She renewed the South Dakota license and her privileges were reinstated. She stated she wanted an Oklahoma license so she could moonlight. Dr. McNeill moved to recommend approval of the application pending satisfactory completion of the file. Ms. Gillespie and Dr. Harris seconded the motion and the vote was unanimous in the affirmative.

There being no further business, the meeting was adjourned. The time was 3:48 p.m.
