**GILBERTO CASTILLO TORRES, PA** appeared with his attorney, Danny Shadid, to discuss results of testing he underwent through Clinical Testing Services. O.U.'s PA Assessment Process was developed to evaluate PAs having difficulties or who may have deficiencies in their education. Ms. Scott advised the Committee that the Board had received several complaints against Mr. Torres and he had been asked to meet with staff. Based on that meeting, Mr. Torres was asked to get the assessment, which showed unacceptable in three out of four categories. Mr. Torres said he had been practicing in psychiatry for 20 years and is not NCCPA certified. One of the complaints said Mr. Torres had lead patients to believe he was a doctor. Mr. Torres says he now wears a nametag with Physician Assistant spelled out. Ms. Scott suggested the Committee give Mr. Torres some recommendations in order to help him avoid future trouble. Lindsey Gillispie recommended that he obtain NCCPA Certification and CME in the area of general medicine. Ms. Scott said staff could also place a letter of zero tolerance in his file stating there would be no tolerance if any further complaints were received. Dan McNeill said the PA Program could offer to have him come and participate with PA and medical students in practicing examining patients. Mr. Torres indicated his willingness to comply with the Committee's recommendations.

Ms. Scott reported on formal Complaints filed against the following Physician Assistants. Toni Michelle Jones, PA had been cited for prescribing to friends without authorization from her supervising physician and for personal substance abuse. Ms. Jones had gone to Bradford for assessment. They had recommended inpatient treatment. Ms. Jones is waiting on money but plans on going there for treatment. Ms. Scott said Ms. Jones is following staff's recommendation and is not practicing.

Suzzie Waldenville, PA had been cited for prescribing violations. She had prescribed to patient without first establishing a relationship with the patient. Her employer had fired her for the incidents. Base on Ms. Waldenville's previous history, the Committee recommended permanent revocation because of patient safety issues.

Amy Walker, PA had been cited substance abuse. She went to the Health Professionals Program but relapsed. She then went to Palmetto for treatment, after leaving treatment, Palmetto asked her to return for a short period of time because of an inappropriate relationship with another patient. Ms. Scott reported that Ms. Walker was scheduled to meet with staff tomorrow. She had agreed not to practice until case is heard by the Board. The Committee discussed approval of her employment at a facility where CDS is not available. The Committee recommended that she be placed on probation with tight monitoring for substance abuse and no access to CDS.

Jere Claunch, PA had been cited for prescribing violations, prescribing without permission of his supervising physician, medical records violations, and prescribed to his wife (CDS). Dan McNeill said the case was especially concerning because it involved deceit between the PA and his supervisor. The Committee suggested a suspension of at least three months, a prohibition on prescribing controlled dangerous substances and re-education on medical ethics and prescribing.

Dan McNeill gave a presentation on trends in supervision of Physician Assistants, Advanced Practice Nurses and allied health professionals. The Board had asked the Committee to look at the extent to which physicians supervise others to investigate whether the practice

might be excessive. He reviewed statistics based on data from the Medical Board and Board of Nursing. The report concluded that there were many variables including levels of supervision, full and part-time supervision, primary versus alternate supervision and practice environments. For those providing direct medical care, it appeared that the actual number is low. Additionally, the Board already has in place a mechanism to limit the number of individuals being supervised. The Committee thanked him for his report. Dr. McNeill said he would be making this presentation to the Board in November.

Mr. Moore asked Dr. McNeill about the PA clinical testing through Clinical Testing Services. Dr. McNeill said the assessment program was designed to evaluate PAs who are having problems or who have been out of practice for a time. The program provides a skill assessment at a fraction of the cost of similar out-of-state programs. Dr. McNeill said the process is set up the same way as Step 2 of the USMLE clinical simulation exams and uses eight, highly-trained, simulated patients. The PA interacts with the patients and then is given time after the encounter to write SOAP notes. The results are scored based on standards established using content experts. If the PA's performance is not acceptable, they can be required to obtain additional CME, regain NCCPA certification, work in a limited practice setting or with increased supervision, or they can be referred for further evaluation out of state.

Dr. Womack asked about the half-day supervision requirement, specifically in cases where the PA is there only one half day per week. Mr. Kelsey said the rules state that the physician must be there at least one half day per week, no matter the length of time the PA is working.

Staff reported a conflict with one of the meeting dates. The Committee changed the July date to July 19<sup>th</sup>.

There being no further business, Dr. Sirajuddin moved to adjourn the meeting. Dr. Moore seconded the motion and the vote was unanimous in the affirmative. The time was 4:46 p.m.
