Minutes of February 25, 2016 Meeting

Having noted a quorum, Mr. Passmore called the meeting to order at 3:00 p.m. The Committee reviewed the Minutes from the August 27, 2015 meeting. Mr. Velasco moved to approve the Minutes as written. Ms. Roberts seconded the motion and the vote was unanimous in the affirmative.

After Committee review, Ms. Roberts moved to recommend approval of the complete application of **ASHLEY BROOKE WILLIAMSON** for Therapeutic Recreation Specialist Olicensure. Mr. Velasco seconded the motion and the vote was unanimous in the affirmative.

Mr. Velasco moved to recommend approval of the incomplete application of **CASSANDRA LYNN TARIN** for Therapeutic Recreation Specialist licensure pending completion of the file. Ms. Roberts seconded the motion and the vote was unanimous in the affirmative. Licensing Staff was directed to advise Ms. Tarin of the documents which were lacking from her file, and to advise her regarding what was required for her to receive a temporary letter to practice.
