Minutes

The Physician Assistant Advisory Committee of the Oklahoma Board of Medical Licensure and Supervision met on October 24, 2023, in accordance with the Oklahoma Open Meeting Act. Advance notice of this regularly scheduled meeting was transmitted to the Oklahoma Secretary of State on November 22, 2022. The notice and agenda were posted on the Board's website on October 17, 2023, at 11:53 a.m. pursuant to 25 O.S. § 311(A)(9).

Having noted a quorum, Mr. Burke called the meeting to order at 3:00 p.m. Barbara Smith called roll to confirm a quorum for purposes of the record.

Following Committee review, Mr. Flinn moved to approve the meeting minutes of August 8, 2023, as written. Ms. Ijams seconded the motion and the vote was unanimous in the affirmative with Mr. Perdue, Dr. Young, Dr. Stone, and Dr. Cox ABSTAINING from the vote.

KEVIN MAXWELL was unable to appear in support of his application for Physician Assistant licensure due to a sudden illness. Mr. Flinn moved to table the application pending a personal appearance before the Committee. Mr. Bosse seconded the motion and the vote was unanimous in the affirmative.

MEGHANN REAM appeared virtually in support of her application for Physician Assistant licensure. In February of this year, her application was approved pending completion of direct onsite supervision for a period of six months with a satisfactory letter from her supervisor and a personal appearance before the Committee at the conclusion thereof. Following review of

the letter presented, Mr. Flinn moved to recommend approval of the application. Dr. Cox seconded the motion and the vote was unanimous in the affirmative.

Next, the Committee reviewed applications for licensure. Dr. Cox moved to recommend approval of the incomplete application(s) for Physician Assistant licensure pending completion of the file(s) as indicated on *Attachment #I* hereto. Dr. Stone seconded the motion and the vote was unanimous in the affirmative.

Ms. Ijams moved to recommend approval of the incomplete application(s) for reinstatement of Physician Assistant licensure pending completion of the file(s) as indicated on *Attachment #1* hereto. Mr. Flinn seconded the motion and the vote was unanimous in the affirmative.

Ms. Ijams moved to recommend approval of the complete application(s) for Physician Assistant licensure as indicated on *Attachment #1* hereto. Mr. Flinn seconded the motion and the vote was unanimous in the affirmative.

Following the application portion of the agenda, Mr. Burke stated he had received several complaints regarding the overall accuracy of the Jurisprudence Examination. At the last meeting, a subcommittee was appointed to review the current exam and recommend amendments, if necessary. Ms. Ijams reported she and the other subcommittee members were able to find the answers in the PA Practice Act and the information posted on the Board's website is accurate. There was only one question that could be somewhat misleading and that question was rewritten by the subcommittee and submitted to Mr. Burke, Committee Chair. Mr. Burke reported that he accepted the revision as presented. Lisa Cullen advised Ms. Ijams and Mr. Burke that she would ensure the exam was updated if they would provide her with the revision which they agreed to do.

Mr. Burke presented proposed amended administrative rules (Okla. Admin. Code 435:15 Physician Assistants) for review, discussion and possible action. Barbara Smith presented a rulemaking timeline and advised that December 22nd was the last day to file rules and have them considered during the 2024 legislative session. The physician members of the Committee had many questions regarding how pharmacists would know if a PA was allowed, under law/rule, to write a Schedule II off-site. The physician members asked that the pharmacists/Pharmacy Board representatives be included in any further discussion regarding rule amendments. Dr. Young moved to table this matter pending a meeting of the subcommittee with MD, DO, PAs, and Pharmacy Board representatives in attendance. Dr. Stone seconded the motion. After further discussion, the vote was called and is recorded below:

Following the vote, Mr. Burke moved that a deadline be set for meetings of the subcommittee and, ideally, two subcommittee meetings will be held within 28 days from today. Mr. Flinn seconded the motion and the vote was unanimous in the affirmative. After the vote, Mr. Kelsey volunteered to contact the subcommittee and set the meetings.

There being no further business, Mr. Burke moved to adjourn the meeting. The time was 4:11 PM.
