

## Minutes

The Athletic Trainers Advisory Committee of the Board of Medical Licensure and Supervision met on August 17, 2022, in accordance with the Open Meeting Act. Advance notice of this amended meeting was transmitted to the Oklahoma Secretary of State on October 15, 2021. The notice and agenda were posted on the agency's website on August 10, 2022 at 2:29 p.m. in accordance with 25 O.S. § 311.(A)(9).

Having noted a quorum, Mr. McKibbin called the meeting to order at 9:00 a.m.

Following Committee review, Mr. Chlouber moved to approve the minutes of August 18, 2021 as written. Dr. Meier seconded the motion and the vote was unanimous in the affirmative.

**MICHAEL MATHIS** appeared in person in support of his application for reinstatement of Athletic Trainer licensure. His license lapsed August of 2020 and he last practiced in March of 2017. He is not currently licensed in any other state. Mr. Mathis explained his activities since he has not practiced. He is fully certified through BOC and wishes to reinstate his license to return to AT practice. He has a job opportunity with Southern Nazarene University. Following discussion, Dr. Meier moved to recommend approval of this application. Mr. Fulton seconded the motion and the vote was unanimous in the affirmative.

**KARIS PARKER** appeared virtually in support of her application for Athletic Trainer licensure and in response to possibly practicing without an Oklahoma license. She has been allegedly practicing since July of 2021 without proper licensure and her application is incomplete. She explained she graduated and passed the BOC, which is current, but did not understand the difference between certification and state licensure. She is currently licensed in Texas. Following discussion, Dr. Northcutt moved to recommend approval of this application pending completion of the file with a Letter of No Tolerance and with a letter sent to Oklahoma City Public Schools Athletic Director and her supervising physician, Seethal Madhavarapu, MD, regarding the requirements of Oklahoma Athletic Trainer Licensure. Dr. Meier seconded the motion and the vote was unanimous in the affirmative.

Mr. McKibbin suggested sending letters via email to all licensed ATs in Oklahoma regarding Oklahoma AT licensure. Licensing staff agreed this could be done via an email blast.

**LIN-KAI WANG** appeared in person in support of his application for reinstatement of Athletic Trainer licensure. His Oklahoma license lapsed in August of 2019 and he last practiced in May of 2019. He is not currently licensed in any other state and his certification through BOC is current. Following discussion, Mr. Chlouber moved to recommend approval of this application. Mr. Fulton seconded the motion and the vote was unanimous in the affirmative.

**ASHTON YOUNG** appeared in person in support of her application for Athletic Trainer licensure and in response to possibly practicing without an Oklahoma license. Her application is incomplete. Ms. Young explained that she was working at Southern Nazarene University as a graduate assistant and anticipating getting a new contract with a new supervising physician quickly. In the interim she was assisting with football players preparing for practice, taping, and providing water, etc. It is her intention to stay with SNU once licensed. Following discussion, Mr. Chlouber moved to recommend approval of this application pending completion of the file. Dr. Northcutt seconded the motion and the vote was unanimous in the affirmative.

The Committee then reviewed applications for licensure. Mr. Chlouber moved to recommend approval of the incomplete applications for Apprentice Athletic Trainer licensure pending completion of the files as shown on **Attachment #1** hereto. Mr. Fulton seconded the motion and the vote was unanimous in the affirmative.

Dr. Northcutt moved to recommend approval of the incomplete applications for Athletic Trainer licensure pending completion of the files as shown on **Attachment #1** hereto. Mr. Chlouber seconded the motion and the vote was unanimous in the affirmative.

Mr. Fulton moved to recommend approval of the complete application for reinstatement of Athletic Trainer licensure as shown on **Attachment #1** hereto. Mr. Chlouber seconded the motion and the vote was unanimous in the affirmative.

Dr. Northcutt moved to recommend approval of the incomplete applications for reinstatement of Athletic Trainer licensure pending completion of the files as shown on **Attachment #1** hereto. Dr. Meier seconded the motion and the vote was unanimous in the affirmative.

Mr. Fulton moved to recommend approval of the complete applications for Athletic Trainer licensure as shown on **Attachment #1** hereto. Mr. Chlouber seconded the motion and the vote was unanimous in the affirmative.

There being no further business, Mr. McKibbin moved to adjourn the meeting. The time was 10:15 a.m.
