#### **Minutes**

Barbara Smith presented a letter from the National Athletic Trainer's Association Board of Certification, Inc., announcing that its name has officially changed to "Board of Certification." She advised that, due to Mr. McKibbin playing a critical role in revising the administrative rules in 2019-2020, all references to that entity were changed to "Board of Certification" or "BOC." The Committee did not take any action in this regard nor was any required.
