Barbara Smith, Executive Secretary, provided an update on the status of the proposed rule revisions to *Okla. Admin. Code 435:35*. She reported that the Notice of Rulemaking Intent was filed with the Secretary of State on November 15, 2019, and was subsequently published on December 16, 2019. The 30-day public comment period ran from December 16, 2019 through January 16, 2020 and a public hearing was held on January 24, 2020 at 9:00 a.m. No comments were received during the public comment period nor at the public hearing. The proposed rule revisions are set on the Medical Board's Agenda for March 5, 2020. The Board will consider adoption of the proposed rule revisions at that time.
