ZACHARIAH ANDERSON, MD – *Review of work hours* – no action required

LYNN DEAN BAGGETT, MD – *Motion to terminate probation with the physician agreeing to certain conditions* – probation terminated with agreement to attend OHPP meetings and to obtain drug testing for an additional year.

ERIC LEE COTTRILL, MD – *Motion to terminate probation* – Probation terminated

DISCIPLINARY MATTERS

STEVEN CONSTANTINE ANAGNOST, MD – *Disciplinary hearing alleging fraud, negligence, and incompetence* – Voluntary Submittal to Jurisdiction accepted requiring completion of CME in the area of billing and medical record keeping, completion of an ACGME-affiliated spine visiting fellowship, payment of a \$10,000 fine, payment of costs and an appearance before the Board providing documentation of successful completion of these terms prior to resuming surgical practice in Oklahoma.

BERNARD FIORAVANTI, MD – *Disciplinary hearing alleging substance abuse, prescribing violations, narcotic law violations, confession of a crime; CDS/narcotics records violations, and inability to practice medicine with reasonable skill and safety – case continued to the November 2013 Board meeting*

JENNIFER GOUCHER, OTA – *Disciplinary hearing alleging obtaining a license by fraud/misrepresentation/concealment of material facts, failure to report adverse action, conviction of a felony, dishonorable or immoral conduct likely to deceive/defraud/harm the public, procuring/aiding/abetting a criminal operation, participation in fraud/abuse, and unauthorized possession or use of CDS – License revoked*

JARRETT G. GREGORY, MD – *Disciplinary hearing alleging prescribing violations, narcotic law violations, CDS/narcotics records violations, medical records violations, violation rules regulating treatment of chronic pain and dishonorable or immoral conduct likely to deceive/defraud/harm the public – Continued to the November 2013 Board meeting*

DIANA HAGER, MD – *Disciplinary hearing alleging dishonorable/immoral conduct, confession of a crime involving antinarcotic laws, prescribing violations, narcotic law violations, medical records violations, and failure to establish a physician/patient relationship – continued until she complete an assessment at CPEP*

JOHN ALLISON HENSLEY, MD – *Disciplinary hearing alleging violation of criminal laws, prescribing violations, narcotic law violations, medical records violations, and dishonorable or immoral conduct likely to deceive/defraud/harm the public – Voluntary Submittal to Jurisdiction accepted imposing a reprimand and 100 hours of community service*

ROBERT MICHAEL HOLBROOK, MD – *Disciplinary hearing alleging dishonorable/immoral conduct, prescribing violations, narcotic law violations, medical records violations, and failure to establish a physician/patient relationship – Voluntary Submittal to Jurisdiction accepted imposing a two-year probation, \$15,000 fine, 200 hours of community service, no prescribing CDS for out-patients and attendance at a comprehensive prescribing course*

GARY PAUL KULA, MD – *Disciplinary hearing alleging fraud or misrepresentation in applying for reregistration of a medical license, incapacity or incompetence to practice medicine and dishonorable or immoral conduct likely to deceive, defraud or harm the public – Case dismissed without prejudice*

SHON WYLIE MCBRIDE, PTA – *Disciplinary hearing alleging violation of terms of probation – License revoked*

HOLLY TINA MYERS, RC – *Disciplinary hearing alleging violation of terms of probation – Voluntary Surrender of License in Lieu of Prosecution accepted*

ABOLGHASEM REZAEI, MD – *Disciplinary hearing alleging dishonorable/immoral conduct, confession of a crime involving antinarcotic laws, prescribing violations, narcotic law violations, and aiding/abetting the unlicensed practice of medicine* – Voluntary Submittal to Jurisdiction accepted imposing a two-year probation with terms including no prescribing CDS Schedules II & III, no authorizing personnel to initiate an order for CDS, no self-prescribing, drug testing, continued counseling, and quarterly reports from the director of the Lawton Residency Program

DAVID HILL STALLCUP, RC – *Disciplinary hearing alleging violation of terms of probation* – Voluntary Submittal to Jurisdiction accepted imposing a five-year term of probation with terms including drug/alcohol testing, counseling, and OHPP meeting attendance.

THOMAS EDWARD TROW, MD – *Disciplinary hearing alleging dishonorable/immoral conduct, prescribing violations, narcotic law violations, medical records violations, and dishonorable or immoral conduct likely to deceive/defraud/harm the public* – Voluntary Submittal to Jurisdiction accepted imposing a nine month suspension from 11/30/12 to 8/30/13 followed by a two-year probation with terms requiring completion of a prescribing course and no prescribing CDS until he completes the course and meets with the Board Secretary

CATHERINE LOUISE WHITE, MD – *Disciplinary hearing alleging incapacity or incompetence to practice medicine* – Case continued until she completes an assessment at K-STAR and any employment she obtains is to be approved by the Board Secretary.

KELLEE YOUKHANA, MD – *Disciplinary hearing alleging dishonorable/immoral conduct, prescribing violations, narcotic law violations, medical records violations, and failure to establish a physician/patient relationship* – Voluntary Submittal to Jurisdiction accepted imposing a reprimand and 100 hours of community service.
