JERRY HERNANDEZ, MD – Disciplinary hearing based on allegations of the violation, or attempted violation, direct or indirect, of any of the provisions of the Oklahoma Allopathic Medical and Surgical Licensure and Supervision Act, either as principal, accessory or accomplice; conviction of a felony or of any offense involving moral turpitude; conviction or confession of a crime involving violation of the laws of this state; dishonorable or immoral conduct which is likely to deceive, defraud, or harm the public; and the Board shall revoke the license of a person licensed by the Board who has a final felony conviction – *Revocation of licensure without right to reapply pending review and approval by the Oklahoma Attorney General.*

AZUKA CASSANDRA EGBUNIWE, MD – Disciplinary hearing based on allegations of the violation, or attempted violation, direct or indirect, of any of the provisions of the Oklahoma Allopathic Medical and Surgical Licensure and Supervision Act; dishonorable or immoral conduct which is likely to deceive, defraud, or harm the public; confession of a crime involving violation of the antinarcotic laws of the federal government or the laws of this state; violating any state or Federal law or regulation relating to controlled substances; Procuring, aiding or abetting a criminal operation; writing a false or fictitious prescriptions for any drugs or narcotics declared by the laws of this state to be controlled or narcotic drugs; prescribing or administering a drug or treatment without sufficient examination and the establishment of a valid physician-patient relationship; prescribing, dispensing or administering of controlled substances or narcotic drugs in excess of the amount considered good medical practice, or prescribing, dispensing or administering controlled substances or narcotic drugs without medical need in accordance with published standards; aiding or abetting, directly or indirectly, the practice of medicine by any person not duly authorized under the laws of this state; allowing another person or organization to use a physician’s license to practice medicine and surgery; and failure to establish a physician/patient relationship prior to providing patient-specific medical services, care or treatment, except in a clearly emergent, life threatening situation – *Voluntary Submittal to Jurisdiction accepted pending review and approval by the Oklahoma Attorney General.*
