MARK REIHELD, MD – Disciplinary hearing based on allegations of prescribing, dispensing or administering of controlled substances or narcotic drugs in excess of the amount considered good medical practice, or prescribing dispensing or administering controlled substances or narcotic drugs without medical need in accordance with published standards – *Voluntary*

Submittal to Jurisdiction accepted

SCOTT PARKHURST TURNER, MD – Disciplinary hearing based on allegations of fraud or misrepresentation in applying for or procuring a medical license or in connection with applying for or procuring periodic re-registration of a medical license; and using a false, fraudulent, or deceptive statement in any document connected with the practice of medicine and surgery – *Dismissed without prejudice*

MARK STEPHEN WILSON, MD – Disciplinary hearing based on allegations of habitual intemperance or the habitual use of habit-forming drugs; and the inability to practice medicine with reasonable skill and safety to patients by reason of drunkenness, excessive use of drugs, narcotics, chemicals, or any other type of material – *Continued to May 7, 2020*

MARK DOUGLAS FOSSEY, MD – Disciplinary hearing based on allegations of failure to establish a physician/patient relationship prior to providing patient-specific medical services, care or treatment; and failure to maintain adequate medical records to support diagnosis, treatment or prescribed medications – *Voluntary Submittal to Jurisdiction accepted*

WILLIAM C. BRADFORD, MD – Disciplinary hearing based on allegations of failure to keep complete and accurate records of purchase and disposal of controlled drugs; purchasing or prescribing any regulated substance in Schedules I through V, as defined by the Uniform Controlled Dangerous Substances Act, for the physician's personal use; and ordering any drug legally classified as a controlled substance for himself – *Voluntary Submittal to Jurisdiction accepted*

JOE BOB ALEXANDER, MD – Disciplinary hearing based on allegations of the violation, or attempted violation, direct or indirect, of any of the provisions of the Oklahoma Allopathic Medical and surgical Licensure and Supervision Act, either as a principal, accessor or accomplice; and violating any state or federal law or regulation relating to controlled substances – *Voluntary Submittal to Jurisdiction accepted*

CHIGURUPATI RAMANA, MD – Plaintiff's Motion for Continuance; *and possible* disciplinary hearing based on allegations of failure to maintain a proper office record; failure to provide a proper and safe medical facility setting and qualified assistive personnel for a recognized medical act, including but not limited to an initial in-person patient examination, office surgery, diagnostic service or any other medical procedure or treatment, and medical records to support diagnosis; gross or repeated negligence in the practice of medicine and surgery; being physically or mentally unable to practice medicine and surgery with reasonable skill and safety; practice or other behavior that demonstrates an incapacity or incompetence to practice medicine and surgery; and obtaining any fee by fraud, deceit, or misrepresentation, including fees from Medicare, Medicaid, or insurance – *Continued to a future date to be set by agreement of the parties*
