WILLIAM DALE WRIGHT, MD – Motion to Enforce Board Order – *Revocation of license with the right to reapply pending the review and approval of the Oklahoma Attorney General*

DAVID G. CALENZANI, MD – Disciplinary hearing based on allegations of violation of any provision of the Oklahoma Allopathic Medical and Surgical Licensure and Supervision Act; prescribing, dispensing or administering of controlled substances or narcotic drugs in excess of the amount considered good medical practice, prescribing, dispensing or administering controlled substances or narcotic drugs without medical need in accordance with pertinent licensing board standards; failure to maintain an office record for each patient which accurately reflects the evaluation, treatment, and medical necessity of treatment of the patient; improper management of medical records; violation of any provision(s) of the medical practice act or the rules and regulations of the Board or of an action, stipulation, or agreement of the Board; and failing to obtain informed consent, based on full and accurate disclosure of risks, before prescribing, dispensing, or administering medical treatment for the

therapeutic purpose of relieving pain – *Voluntary Submittal to Jurisdiction accepted*

JAMES E. LYNCH, MD – Disciplinary hearing based on allegations of habitual intemperance or the habitual use of habit-forming drugs in violation of Title 59 O.S. § 509(4), dishonorable or immoral conduct which is likely to deceive, defraud, or harm the public in violation of Title 59 O.S. § 509(8); failure to maintain an office record for each patient which accurately reflects the evaluation, treatment and medical necessity of treatment of the patient in violation of Title 59 O.S. § 509(18); the inability to practice medicine with reasonable skill and safety to patients by reason of age, illness, drunkenness, excessive use of drugs, narcotics, chemicals, or any other type of material or as a result of any mental or physical condition in violation of Title 59 O.S. § 509(15) and Okla. Admin. Code 435:10-7-4(40); and the habitual or excessive use of any drug which impairs the ability to practice medicine with reasonable skill and safety to the patient in violation of Okla. Admin. Code 435:10-7-4(3) – *Voluntary Submittal to Jurisdiction accepted.*

TEMP RAY PATTERSON, MD – Possible (oral) Motion to Continue, and dependent upon the ruling on the continuance, possible disciplinary hearing based on allegations of conviction of any felony in or without the State of Oklahoma and whether in a state or federal court, pursuant to Title 59 O.S. §513(a)(3); Okla. Admin. Code 435:10-7-4(10) – *Surrender in Lieu of Prosecution accepted.*
