

## Minutes

The Occupational Therapy Advisory Committee of the Board of Medical Licensure and Supervision met on August 8, 2023, in accordance with the Oklahoma Open Meeting Act. Advance notice of this regularly scheduled meeting was transmitted to the Oklahoma Secretary of State on November 22, 2022. The notice and agenda were posted on the Board's website on July 27, 2023 at 11:45 AM pursuant to 25 O.S. § 311(A)(9).

Having noted a quorum, Barbara Smith, Executive Secretary, called the meeting to order at 9:00 a.m. and called roll for the record.

Following Committee review, Ms. Garza moved to accept the meeting minutes of April 18, 2023, as written. Ms. White seconded the motion and the vote was unanimous in the affirmative.

The Committee then considered nominations for the roles of Committee Chair and Vice-Chair. Ms. Garza nominated Jennifer Wallace to serve as Committee Chair. Ms. Wallace accepted the nomination and Ms. White seconded the motion. The vote was unanimous in the affirmative.

Ms. Garza moved to nominate Mary White as Vice-Chair. Ms. White accepted the nomination and Ms. Wallace seconded the motion. The vote was unanimous in the affirmative.

**RYAN BARBER** appeared personally in support of his application for Occupational Therapy Assistant licensure. He last practiced in November of 2014 and his Texas license is currently suspended. Following review and discussion, Ms. White moved to recommend tabling the application pending resolution of his Texas disciplinary matter including the suspension of his license. Ms. Garza seconded the motion and the vote was unanimous in the affirmative.

**JERRY DURHAM** appeared personally in support of his application for Occupational Therapist licensure. His license expired in January of 2020 and he provided 16 CEUs for 2023 and 10 CEUs for 2019. His application is complete. The applicant stated he believes he submitted approximately 65 hours of CEUs. After recalculation of the submitted CEUs, Ms. Cullen determined that he provided 63 CEUs for 2023. His current practice plan is to return to work for his former supervisor on a part-time basis. Ms. White moved to recommend approval of the application pending receipt of proof of a total of 68 CEUs. Ms. Wallace seconded the motion and the vote was unanimous in the affirmative.

**KATRESA GEAN** appeared virtually in support of her application for Occupational Therapy Assistant licensure. Her Oklahoma license expired on October 31, 2023, she last practiced in August of 2022, and her Kansas license expired March 31, 2023. Applicant's NBCOT certification expired March of 2022. Her application is complete. Ms. Gean advised the Committee that her goal is to practice OT in rural Oklahoma since she lives on the Oklahoma/Kansas border. Ms. White moved to recommend approval of the application pending receipt of proof of a total of 10 CEUs. Ms. Garza seconded the motion and the vote was unanimous in the affirmative.

**HEATHER HANSEN** appeared virtually in support of her application for Occupational Therapist licensure. She last practiced in January of 2018 and her NBCOT expires on March 31, 2026. She is not licensed in any other state nor has she ever held an Oklahoma license. The application is complete. Ms. Cullen advised that the applicant had provided 44.5 CEUs for 2023. The applicant said she had over 50 hours of CEUs and Ms. Cullen stated she would recalculate the hours.

*The Committee took a 10-minute recess to allow Ms. Cullen to make copies of information for Committee review.*

Upon reconvening, it was determined that the information provided for Committee review dealt with a previous matter that had since been resolved.

Following much discussion and review, the applicant agreed that her California license had expired on January 31, 2017. Ms. White moved to recommend approval of the application pending receipt of proof of a total of 160 CEUs as allowed under Okla. Admin. Code 435:30-1-3(7)(8)(B). Ms. Garza seconded the motion and the vote was unanimous in the affirmative.

**CHRISTA PULLIAM** appeared virtually in support of her application for Occupational Therapy Assistant licensure. She last practiced on October 31, 2019, and her Texas license expired on May 31, 2022. Her application is complete. Following review and discussion, Ms. White moved to recommend approval of the application pending receipt of proof of a total 30 CEUs as allowed under Okla. Admin. Code 435:30-1-5. Ms. Wallace seconded the motion and the vote was unanimous in the affirmative with Ms. Garza ABSTAINING.

**SHAWNA SCHLIESMAN** appeared virtually in support of her application for Occupational Therapy Assistant licensure. She last practiced in 2019 and her NBCOT expires in March of 2024. She has never held an Oklahoma license. Her Colorado license expired on March 31, 2021.

The applicant lost her virtual connection and the Committee moved to the next matter on the agenda.

After reconnection was established, and following further review and discussion, Ms. White moved to recommend approval of the application pending receipt of proof of 58 CEUs allowed under Okla. Admin. Code 435:30-1-5. Ms. Garza seconded the motion and the vote was unanimous in the affirmative.

Ms. Cullen announced that **KARIANN SMITH** withdrew her application for Occupational Therapy Assistant licensure.

**BRENDA VALENCIA** appeared virtually in support of her application for Occupational Therapy Assistant licensure. Her license expired on January 30, 2021 and she last practiced in

May of 2020. The applicant's NBCOT license expired May 31, 2020 and she does not hold licensure in any other state. Following review and discussion, Ms. White moved to recommend approval pending receipt of proof of completing a total of 62 CEUs as allowed under Okla. Admin. Code. 435:30-1-5. Ms. Wallace seconded the motion and the vote was unanimous in the affirmative.

Next, the Committee reviewed the supervision logs provided by **ANNA FOGLE, OT**, as requested by the Committee in its meeting of April 2023. An appearance by Ms. Fogle was not required. Ms. Cullen advised that Ms. Fogle was no longer supervising additional COTAs and no action was necessary in this matter.

The Committee then reviewed applications for licensure. Ms. Garza moved to recommend approval of the incomplete application(s) for Occupational Therapy Assistant licensure pending completion of the file(s) as listed on *Attachment #1* hereto. Ms. White seconded the motion and the vote was unanimous in the affirmative.

Ms. Garza moved to recommend approval of the complete application(s) for reinstatement of Occupational Therapy Assistant licensure as listed on *Attachment #1* hereto. Ms. White seconded the motion and the vote was unanimous in the affirmative.

Ms. White moved to recommend approval of the complete application(s) for Occupational Therapy Assistant licensure as listed on *Attachment #1* hereto. Ms. Garza seconded the motion and the vote was unanimous in the affirmative.

Ms. Garza moved to recommend approval of the incomplete application(s) for Occupational Therapist licensure pending completion of the files as listed on *Attachment #1* hereto. Ms. White seconded the motion and the vote was unanimous in the affirmative.

Ms. Garza moved to recommend approval of the complete application(s) for Occupational Therapist licensure as listed on *Attachment #1* hereto. Ms. Wallace seconded the motion and the vote was unanimous in the affirmative.

Next, Valeska Barr presented previously reviewed CEU courses. Ms. White moved to recommend approval of the CEU courses listed on *Attachment #2* hereto which were previously recommended for approval by the reviewers. Ms. Garza seconded the motion and the vote was unanimous in the affirmative.

There being no further business, Ms. Gorman moved to adjourn the meeting. The time was 11:48 AM.
