Ms. Garza led a discussion regarding "Continuing Education" pursuant to Okla. Admin. Code 439-30-1-5. Following a thorough review of the rules and a discussion of the committee, Ms. Garza issued a Staff Directive that staff follow the American Occupational Therapy Association ("AOTA") calculation of CE hours as opposed to the National Board for Certification in Occupational Therapy ("NBCOT") PDU calculations and to provide notice of this matter to all licensees.

Next, the OTA classes of Caddo Kiowa Technology Center and Oklahoma City Community College were welcomed. The students asked questions of the committee and thanked the members for allowing them to virtually attend the meeting today.

There being no further business, Ms. Gorman moved to adjourn the meeting. The time was 10:19 AM.
