Physical Therapy Advisory Committee

(Corrected) Minutes

The Physical Therapy Committee of the Board of Medical Licensure and Supervision met on April 11, 2023, at 9:00 AM at the office of the Board at 101 NE 51^{st} Street, Oklahoma City, Oklahoma. This regular meeting is being held consistent with the Oklahoma Open Meeting Act. Advance notice of this meeting was transmitted to the Oklahoma Secretary of State on November 22, 2022, and posted on the Board's website on April 7, 2023, at 10:40 AM in accordance with Title 25 O.S. § 311(A)(9).

Having noted a quorum, Ms. Berry called the meeting to order at 9:00 AM. Barbara Smith confirmed the quorum by roll call for the record.

Following review, Ms. Mason moved to approve the February 14, 2023, minutes as written. Ms. Lawrence seconded the motion and the vote was unanimous in the affirmative.

BURGUNDY HOWES, Physical Therapist, appeared virtually in support of her request to supervise additional Physical Therapist Assistants. She appeared in May of 2022 and a personal appearance was required at the end of that approved term, but she is also re-requesting to supervise additional Physical Therapist Assistants. Brand Hartsell the owner of First Care Rehabilitation, Inc., appeared on behalf of Ms. Howes. The Committee was disappointed to learn that the clinic had made no attempts to hire an additional PT to assist with supervisory duties. The Committee made it clear their role was not to support a business model, but to protect the public. After discussion, Ms. Mason moved to recommend granting the request of **BURGUNDY HOWES** to supervise one additional PTA for a total of four PTAs for a period of one year with a personal appearance and supervision plan presented to the Committee at the conclusion thereof, in addition to providing proof of attempts at employing an additional PT. Ms. Lawrence seconded the motion and the vote was unanimous in the affirmative. **SHELBY MARSH,** applicant, Physical Therapist Assistant licensure, appeared virtually in support of her request to sit for the FSBPT exam a third time and for special accommodations while testing. Ms. Marsh states she hopes to retake the exam later in July of this year. She presented her study plan as well as her need for special accommodations for Committee review. Following discussion, Ms. Lawrence moved to recommend allowing her to sit for the FSBPT exam a third time with the special accommodation of time and a half. Ms. Mason seconded the motion and the vote was unanimous in the affirmative.

STEVEN WILKINSON, applicant, Physical Therapist Assistant licensure, appeared virtually in support of his request for the Committee to reconsider their recommendation for supervision of December 6, 2022. Mr. Wilkinson stated he has had trouble finding an employer who will accommodate the 88 days of supervision as recommended by the Committee and approved by the Board. Ms. Mason moved to recommend denying the request for reconsideration of the required supervision. Ms. Lawrence seconded the motion and the vote was unanimous in the affirmative.

Next, the Committee reviewed applications for licensure. Ms. Mason moved to recommend approval of the incomplete application(s) for Physical Therapist Assistant licensure as identified on *Attachment #1* hereto pending completion of the files. Ms. Lawrence seconded the motion and the vote was unanimous in the affirmative.

Ms. Mason moved to recommend approval of the complete application(s) for Physical Therapist Assistant licensure as identified on *Attachment #1* hereto. Ms. Lawrence seconded the motion and the vote was unanimous in the affirmative.

Ms. Mason moved to recommend approval of the incomplete application(s) for Physical Therapist licensure as identified on *Attachment #1* hereto pending completion of the file. Ms. Lawrence seconded the motion and the vote was unanimous in the affirmative.

Ms. Mason moved to recommend approval of the complete application(s) for reinstatement of Physical Therapist licensure as identified on *Attachment #1* hereto. Ms. Lawrence seconded the motion and the vote was unanimous in the affirmative.

Ms. Mason moved to recommend approval of the incomplete application(s) for reinstatement of Physical Therapist licensure as identified on *Attachment #1* hereto pending completion of the file. Ms. Lawrence seconded the motion and the vote was unanimous in the affirmative.

Ms. Mason moved to recommend approval of the complete application(s) for Physical Therapist licensure as identified on *Attachment #1* hereto. Ms. Lawrence seconded the motion and the vote was unanimous in the affirmative.

Ms. Mason moved to recommend approval of the PT Courses (CEUs) recommended for approval by subcommittee as identified on *Attachment* #2 hereto. Ms. Lawrence seconded the motion and the vote was unanimous in the affirmative.

Ms. Mason moved to recommend approval of the PT CEU Course Providers recommended for approval by subcommittee as identified on *Attachment #3* hereto. Ms. Lawrence seconded the motion and the vote was unanimous in the affirmative.

Mady Martin, Assistant Attorney General, advised the Committee regarding the United States Department of Transportation's Request for Clarification regarding PT Scope of Practice as it relates to conducting the testing and physical examination of body systems required by the USDOT. In March of 2020, Thomas Schneider, Assistant Attorney General, who was serving as the Committee's legal advisor at that time advised the Committee there was nothing in the law or rules that prohibits PTs from conducting DOT examinations/evaluations. He relied upon Title 59 O.S. § 887.17.A.3 and 4 in rendering his legal opinion. Recently, upon further review, Mr. Schneider has withdrawn his earlier legal analysis and it is now before the Committee for determination.

Ms. Martin stated that she also reviewed Title 59 O.S. § 887.17.A.3 and 4, and does not believe there is any instance where these apply to performing DOT examinations/evaluations:

"3. Nothing in the Physical Therapy Practice Act shall prevent a physical therapist from performing screening and educational procedures within the scope of physical therapy practice without a physician referral.

"4. Nothing in the Physical Therapy Practice Act shall prevent a physical therapist from performing services that are provided for the purpose of fitness, wellness, or prevention that is not related to the treatment of an injury or ailment."

Ms. Martin then referred the Committee to the terms "Educate" and "Screen" as defined in Okla. Admin. Code 435:20-5-5. In closing, Ms. Martin also offered 59 O.S. §887.2.2 for the Committee's review as it relates to the "Practice of Physical Therapy."

The Committee was clear that, while they do perform many types of pre-work screens as well as return to work/fit for duty evaluations, there are some evaluation requirements on the current DOT form that they believe fall outside of their current scope of practice. After further discussion, Ms. Mason moved to recommend finding that some of the DOT examination/evaluation requirements as presented on April 11, 2023 fall outside of the scope of the Oklahoma Physical Therapy Practice Act. Ms. Lawrence seconded the motion and the vote was unanimous in the affirmative.

Next, the Committee considered nominations for the election of Federation of State Boards of Physical Therapy 2023 Voting Delegate and Alternate Delegate. Following discussion, Ms. Mason moved to nominate Kelly Berry to serve as Voting Delegate. Ms. Berry accepted the nomination. Ms. Lawrence seconded the motion and the vote was unanimous in the affirmative. Ms. Berry nominated Deb Mason to serve as Alternate Delegate. Ms. Mason accepted the nomination. Ms. Lawrence seconded the motion and the vote was unanimous in the affirmative.

There being no further business, Ms. Berry adjourned the meeting. The time was 10:05 AM.
