

Physical Therapy Advisory Committee  
Minutes

The Physical Therapy Committee of the Board of Medical Licensure and Supervision met on October 22, 2024, at 9:00 a.m. at the office of the Board at 101 NE 51<sup>st</sup> Street, Oklahoma City, Oklahoma. This meeting is being held consistent with the Oklahoma Open Meeting Act. Advance notice of this meeting was transmitted to the Oklahoma Secretary of State on December 1, 2023, and posted on the Board's website on October 11, 2024, at 11:15 a.m. in accordance with Title 25 O. S. § 311(A)(9).

Having noted a quorum, Ms. Mason called the meeting to order at 9:00 a.m. Barbara Smith confirmed the quorum via roll call for purposes of the record.

Following Committee review, Ms. Chamberlain moved to approve the minutes of the August 6, 2024, meeting as written. Ms. Lawrence seconded the motion and the vote was unanimous in the affirmative.

**CORLISS COLLINS** appeared virtually in support of his application for Physical Therapist Assistant licensure. The application is complete and was previously tabled in April of this year. His license lapsed in January of 2022 and he last practiced in August of 2021. He is not currently licensed in any other state. He has not currently obtained any CEUs. Ms. Lawrence moved to recommend approval of the application pending completion of the file to include completion of 40 days of direct supervision and obtaining 60 CEUs. Ms. Chamberlain seconded the motion and the vote was unanimous in the affirmative.

**OLIE DUNCAN** appeared virtually in support of her application for Physical Therapist Assistant licensure. Her Oklahoma license lapsed on January 31, 2024. She last practiced in December of 2022, and her application is incomplete. Ms. Lawrence moved to recommend approval of the application pending completion of the file to include completion of 12 days of direct supervision with an adequate performance evaluation from the supervising physical therapist at the conclusion thereof and completion of 60 CEUs. Ms. Chamberlain seconded the motion and the vote was unanimous in the affirmative.

**MYSHAL (JONES) OLIVE** appeared virtually in support of her application for Physical Therapist Assistant licensure. Her license expired in 2018 and she last practiced in March of 2016. She appeared before the Committee in December of 2019 and recommendations were made at that time which were not met. Following review and discussion, Ms. Lawrence moved to recommend approval of the application pending completion of the file to include completion of 150 days of direct supervision with an adequate performance evaluation from the supervising physical therapist at the conclusion thereof and completion of 120 CEUs. Ms. Chamberlain seconded the motion and the vote was unanimous in the affirmative.

**DANIELLE SMITH**, applicant, Physical Therapist Assistant, appeared virtually in support of her request to sit for the Federation of State Boards of Physical Therapy exam for a third time. Following review and discussion, Ms. Lawrence moved to recommend approving the request. Ms. Chamberlain seconded the motion and the vote was unanimous in the affirmative.

**ERICA TAYLOR**, applicant, Physical Therapist Assistant, appeared virtually in support of her request to sit for the Federation of State Boards of Physical Therapy exam for a third time. Following review and discussion, Ms. Lawrence moved to recommend approving the request. Ms. Chamberlain seconded the motion and the vote was unanimous in the affirmative.

**MEGAN THOMAS** appeared virtually in support of her application for Physical Therapist Assistant licensure. Her license lapsed in January of 2023 and she last practiced in 2015. She does not currently plan to re-enter practice at this time because she is currently employed as a private school administrator. Following review and much discussion, it was the applicant's wish for the Committee to table her application. It was discussed that Ms. Thomas will need to reach out to the Licensing Department when she is ready to appear. Ms. Lawrence moved to table the application pending personal appearance before the Committee. Ms. Chamberlain seconded the motion and the vote was unanimous in the affirmative.

Next, the Committee reviewed applications as indicated below:

1. Ms. Lawrence moved to recommend approval of the incomplete application(s) for Physical Therapist Assistant licensure as shown on *Attachment #1* pending completion of the file(s). Ms. Chamberlain seconded the motion and the vote was unanimous in the affirmative.
2. Ms. Lawrence moved to recommend approval of the complete application(s) for Physical Therapist Assistant licensure as shown on *Attachment #1*. Ms. Chamberlain seconded the motion and the vote was unanimous in the affirmative.
3. Ms. Lawrence moved to recommend approval of the incomplete application(s) for Physical Therapist licensure pending completion of the file(s) as shown on *Attachment #1*. Ms. Chamberlain seconded the motion and the vote was unanimous in the affirmative.
4. Ms. Lawrence moved to recommend approval of the complete application(s) for Physical Therapist licensure as shown on *Attachment #1*. Ms. Chamberlain seconded the motion and the vote was unanimous in the affirmative.

Ms. Lawrence moved to recommend ratification of the continuing education courses and providers previously reviewed and recommended for approval by the CEU/PDU Review Subcommittee from August 1, 2024 through October 1, 2024, pursuant to applicable rule. Ms. Chamberlain seconded the motion and the vote was unanimous in the affirmative.

There being no further business, Ms. Mason adjourned the meeting. The time was 9:46 a.m.
