Having noted a quorum, Mr. Burke called the meeting to order at 3:00 p.m.

Following Committee review, Dr. Young moved to approve the meeting minutes of October 20, 2022, as written. Mr. Flinn seconded the motion and the vote was unanimous in the affirmative with Ms. Harrison ABSTAINING.

### \*Dr. Cox joined the meeting.

Next, the Committee considered nominations for the role of Committee Chair. Mr. Flinn moved to nominate Jeff Burke to serve another term in that role. Mr. Burke accepted the nomination. Ms. Douglas seconded the motion and the vote was unanimous in the affirmative.

**RICHARD HECKER** appeared virtually in support of his application for Physician Assistant licensure. He last practiced in April of 2020, and he would like to re-enter practice as volunteer staff with medical missions and/or an inner city care facility. Following review and discussion, Mr. Flinn moved to approve the application. Ms. Ijams seconded the motion and the vote was unanimous in the affirmative.

LAURA MILLER appeared personally in support of her application for Physician Assistant licensure. This application is complete and she successfully retook her certification exam. She plans to shadow PAs at the Social Security Disability clinic and hopes to work there full time after licensed. Following review and discussion, Mr. Flinn moved to approve the application. Mr. Bosse seconded the motion and the vote was unanimous in the affirmative.

MEGHANN REAM appeared virtually in support of her application for Physician Assistant licensure. Her application is complete. She has not practiced since she graduated in October of 2018, but her certification is active through 2024. Ms. Ream explained that she moved to Nashville, Tennessee which, she stated, "is advanced practice nurse heavy" and she was unable to gain employment as a PA while there. She advised she is up to date with required CMEs. Following review and discussion, Dr. Cox moved to approve the application pending completion of direct onsite supervision for a period of six months with a satisfactory letter from her supervisor and a personal appearance before the committee at the conclusion thereof. Dr. Young seconded the motion and the vote was unanimous in the affirmative.

**LE TCHEN** appeared virtually in support of her application for Physician Assistant licensure. Her application is incomplete. She last practiced in February of 2013, but she is currently certified and holds active licenses in Kansas and Texas. Following review and discussion, Mr. Flinn moved to table the application until the next meeting (April 2023). Ms. Douglas seconded the motion and the vote was unanimous in the affirmative.

Next, the Committee reviewed applications for licensure. Ms. Ijams moved to recommend approval of the incomplete applications for Physician Assistant licensure pending completion of the files as indicated on *Attachment #1* hereto. Mr. Bosse seconded the motion and the vote was unanimous in the affirmative.

Mr. Flinn moved to recommend approval of the incomplete application of **JENNIFER ANNE JOHNSTAD** for reinstatement of Physician Assistant licensure pending completion of the file as indicated on *Attachment #1* hereto. Ms. Douglas seconded the motion and the vote was unanimous in the affirmative.

Ms. Ijams moved to recommend approval of the complete applications for Physician Assistant licensure as indicated on *Attachment #1* hereto. Mr. Bosse seconded the motion and the vote was unanimous in the affirmative.

Mr. Flinn provided an update on current committee members and terms of service expiration. Barbara Smith will contact the necessary entities regarding nominees with the exception of OAPA, which Mr. Flinn will notify of the upcoming PA vacancy.

There being no further business, Mr. Burke moved to adjourn the meeting. The time was 3:37 PM.
