Minutes

The Physician Assistant Advisory Committee of the Oklahoma Board of Medical Licensure and Supervision met on April 18, 2023, in accordance with the Oklahoma Open Meeting Act. Having noted a quorum, Mr. Burke called the meeting to order at 3:00 PM.

Following Committee review, Dr. Stone moved to approve the meeting minutes of February 7, 2023, as written. Mr. Flinn seconded the motion and the vote was unanimous in the affirmative with Dr. Womack abstaining.

MAURICE LANDERS appeared virtually in support of his application for Physician Assistant licensure. He did not complete his application so there was no practice history for the Committee to review. He was previously NCCPA certified but not licensed in any other state based on the information received. Mr. Landers advised he was a licensed pharmacist in Texas. He volunteered in health services but his Virginia PA license expired in 2003. He has a pharmacy license in Texas. He would like to eventually retire from pharmacy and practice as a traveling PA. He wants to shadow an MD or PA to gain experience before retaking the PANRE. Dr. Cox pointed out that it is not necessary to have a license to shadow a healthcare provider. Following discussion, Mr. Flinn moved to table the application pending Applicant successfully retaking the certification

exam and obtaining all required CME. Dr. Womack seconded the motion and the vote was unanimous in the affirmative.

Next, the Committee reviewed applications for licensure. Mr. Flinn moved to recommend approval of the incomplete application(s) for Physician Assistant licensure pending completion of the file(s) as indicated on *Attachment #I* hereto. Dr. Stone seconded the motion and the vote was unanimous in the affirmative.

Mr. Flinn moved to recommend approval of the complete application(s) for reinstatement of Physician Assistant licensure as indicated on *Attachment #1* hereto. Dr. Womack seconded the motion and the vote was unanimous in the affirmative.

Dr. Womack moved to recommend approval of the incomplete application(s) for reinstatement of Physician Assistant licensure pending completion of the file(s) as indicated on *Attachment #1* hereto. Mr. Flinn seconded the motion and the vote was unanimous in the affirmative.

Dr. Womack moved to recommend approval of the complete application(s) for Physician Assistant licensure as indicated on *Attachment #1* hereto. Mr. Flinn seconded the motion and the vote was unanimous in the affirmative.

Valeska Barr provided an update on Physician Assistants Required to Obtain 40 Hours (of) CME in 2023 for 2023 Renewal as of April 4, 2023 as indicated on *Attachment #2* hereto. Ms. Barr explained that she has not yet received the names from the Oklahoma Academy of Physician Assistants of licensees who will be required to obtain double CME hours. She expects to have that information for Committee review/action at the next meeting. No Committee action was required at this time.

Jeff Burke presented proposed Guidelines for Inactive Physician Assistants Wishing to Re-Enter into Clinical Practice. Mr. Burke stated he intended this to be used as an aid for the Committee and if the Committee finds that any or all of the guidelines need to be enforceable, the Committee may consider the rulemaking process at that time. No formal action was taken at this time. Mady Martin with the Oklahoma Attorney General's office will review the proposed guidelines and make suggested changes, if necessary, for the Committee's consideration.

Jeff Burke presented a request for appointment of Jurisprudence Examination Subcommittee. Mr. Burke stated he was hoping to have the program directors serve on the subcommittee and asked that this matter be tabled. Dr. Womack moved to table this matter until the next committee meeting. Mr. Flinn seconded the motion and the vote was unanimous in the affirmative.

Jeff Burke presented inaccuracies on the Medical Board's Physician Assistant Website Profile and stated that "primary" and "alternate supervision" needs to be changed and asked that all forms be modernized. Valeska Barr explained that OK Interactive monitors that information and several requests have been placed in this regard. Mr. Burke also requested that "Delegating" be added before "Physician" on the profile.

There being no further business, Mr. Burke moved to adjourn the meeting. The time was 3:51 PM.
