Having noted a quorum, Mr. Burke called the meeting to order at 3:00 PM. Barbara Smith called roll to establish a quorum for the record.

Following Committee review, Mr. Flinn moved to approve the meeting minutes of April 18, 2023, as written. Ms. Douglas seconded the motion and the vote was unanimous in the affirmative.

Next, the Committee reviewed applications for licensure. Ms. Douglas moved to recommend approval of the incomplete application(s) for Physician Assistant licensure pending completion of the file(s) as indicated on *Attachment #1* hereto. Ms. Ijams seconded the motion and the vote was unanimous in the affirmative.

Ms. Ijams moved to recommend approval of the complete application(s) for reinstatement of Physician Assistant licensure as indicated on *Attachment #1* hereto. Mr. Flinn seconded the motion and the vote was unanimous in the affirmative.

Ms. Ijams moved to recommend approval of the incomplete application(s) for reinstatement of Physician Assistant licensure pending completion of the file(s) as indicated on *Attachment #1* hereto. Ms. Douglas seconded the motion and the vote was unanimous in the affirmative.

Ms. Ijams moved to recommend approval of the complete application(s) for Physician Assistant licensure as indicated on *Attachment #1* hereto. Mr. Bosse seconded the motion and the vote was unanimous in the affirmative.

Valeska Barr provided an update on Physician Assistants Required to Obtain 40 Hours (of) CME in 2023 for 2023 Renewal as of August 8, 2023, as indicated on *Attachment #2* hereto. Ms. Barr explained this list was provided by the Oklahoma Association of Physician Assistants and this information is in addition to the information received in April. In closing she advised there are a total of 92 physician assistants that are required to obtain double CME hours in order to renew this year. There was no action required of the Committee on this matter.

Mr. Burke presented a request for volunteers to sit on a Jurisprudence Examination Subcommittee to review and make recommendations for amendments to the exam, as necessary. Following discussion, Mr. Perez, Ms. Harrison and Ms. Ijams volunteered to serve in that capacity. Mr. Burke then moved to nominate Mr. Perez, Ms. Harrison and Ms. Ijams to sit on the Jurisprudence Examination Subcommittee. Mr. Flinn seconded the motion and the vote was unanimous in the affirmative.

Mr. Burke announced that there was not a quorum present, pursuant to law, to allow for the review, discussion and action on any proposed amended administrative rules (OAC 435:15).

There being no further business, Mr. Burke moved to adjourn the meeting. The time was 3:23 PM.
