

Minutes

The Respiratory Care Advisory Committee of the Board of Medical Licensure and Supervision met on August 18, 2022. This regular meeting was held consistent with the Oklahoma Open Meeting Act. Mr. Grantz, having determined a quorum, called the meeting to order at 11:30 a.m.

Ms. Smith introduced Mady Martin, AAG, Committee Legal Advisor. The Committee welcomed her.

Following review, Dr. Royder moved to approve the minutes of May 19, 2022, as written. Ms. Beard seconded the motion and the vote was unanimous in the affirmative.

BREYANN HUGHES appeared virtually in support of her application for Respiratory Care Practitioner licensure. Her application is complete. She applied for her license on June 16, 2022 but worked previous to that under an expired Provisional Respiratory Care Practitioner license. Ms. Hughes stated she has learned a lesson and it was an honest mistake. Mr. Moss moved to recommend approval of this application based on her personal appearance before the Committee today. Dr. Royder seconded the motion and the vote was unanimous in the affirmative.

JESSICA RICHTER appeared virtually in support of her application for Respiratory Care licensure. Her application is complete. She has kept current with her continuing education credit requirements but has not practiced since 2013. Mr. Moss moved to recommend approving

the application pending successfully completing direct supervision for a period of ninety days with a report provided to the Committee regarding applicant's performance at the conclusion thereof. Dr. Royder seconded the motion and the vote was unanimous in the affirmative.

DAVID STEINMANN appeared in person in support of his application for Respiratory Care Practitioner licensure. His application is currently incomplete. He has never held an Oklahoma license and has not practiced in the previous 12 months. He is currently licensed in Missouri and that license expires in 2024. He is current with his continuing education units. Ms. Beard moved to recommend approving the application pending completion of the file to include successfully completing direct supervision for a period of ninety days with a report provided to the Committee regarding applicant's performance at the conclusion thereof. Ms. Crouch seconded the motion and the vote was unanimous in the affirmative.

MARY WELCH did not appear in support of her application for Respiratory Care Practitioner licensure. Dr. Royder moved to recommend tabling this application pending a personal appearance before the Committee. Ms. Beard seconded the motion and the vote was unanimous in the affirmative.

Next, the Committee reviewed applications for licensure. Ms. Beard moved to recommend approval of the incomplete applications for Provisional Respiratory Care Practitioner licensure as identified on the pages attached as **Attachment #1** hereto pending completion of the files. Dr. Royder seconded the motion and the vote was unanimous in the affirmative.

Dr. Royder moved to recommend approval of the incomplete applications for Respiratory Care Practitioner licensure as identified on the pages attached as **Attachment #1** hereto pending completion of the files. Ms. Beard seconded the motion and the vote was unanimous in the affirmative.

Ms. Beard moved to recommend approval of the complete application for reinstatement of Respiratory Care Practitioner licensure as identified on the pages attached as **Attachment #1** hereto. Dr. Royder seconded the motion and the vote was unanimous in the affirmative.

Dr. Royder moved to recommend approval of the incomplete applications for reinstatement of Respiratory Care Practitioner licensure as identified on the pages attached as **Attachment #1** hereto pending completion of the files. Mr. Moss seconded the motion and the vote was unanimous in the affirmative.

Ms. Beard moved to recommend approval of the complete applications for Respiratory Care Practitioner licensure as identified on the pages attached as **Attachment #1** hereto. Dr. Royder seconded the motion and the vote was unanimous in the affirmative.
