Minutes

The Respiratory Care Advisory Committee of the Board of Medical Licensure and Supervision met on August 15, 2023. This regular meeting was held consistent with the Oklahoma Open Meeting Act. Advance notice of this meeting was transmitted to the Oklahoma Secretary of State on November 22, 2022, and posted on the Board's website on August 7, 2023, at 8:29 AM pursuant to 25 O.S. § 311(A)(9).

Mr. Grantz, having noted a quorum, called the meeting to order at 11:30 AM. Barbara Smith called roll to establish the quorum on the record.

Following review, Dr. Royder moved to approve the minutes of April 25, 2023, as written. Ms. Beard seconded the motion and the vote was unanimous in the affirmative.

MELYNDA CLOW appeared virtually in support of her application for Respiratory Care Practitioner licensure. She last practiced in August of 2014 and her Oklahoma license expired in January of 2021. She is currently certified but is not currently licensed in any other state. The applicant stated she worked through January of 2018 at Cornerstone Hospital in Broken Arrow, Oklahoma, and has been home with her children since that time. She has obtained CEUs which she will submit to our licensing department. Following review and discussion, Mr. Moss moved to recommend approval of the application pending completion of the file to including proof of completing 12 CEUs and completing three months of direct supervision with the supervising therapist to provide a report to the committee on the applicant's performance at the conclusion thereof. Dr. Royder seconded the motion and the vote was unanimous in the affirmative.

Ms. Barr announced that **GINA COX** has withdrawn her application for Respiratory Care Practitioner licensure.

ERIC PLATT appeared virtually in support of his application for Respiratory Care Practitioner licensure. He graduated in May of 2016, his NBRC expires November 30 of 2026 and he is currently licensed in other states. The applicant stated he obtains approximately 15 CEUs per year to keep his licensure current in other states. Following review and discussion, Ms. Beard moved to recommend approval of the application pending completion of the file. Mr. Moss seconded the motion and the vote was unanimous in the affirmative.

NANCY YANG did not appear in support of her application for Respiratory Care Practitioner licensure. Dr. Royder moved to recommend tabling this application pending a personal appearance before the committee. Mr. Moss seconded the motion and the vote was unanimous in the affirmative.
